- After that date; the jury committee continues to accept applications until the show is full.
- We limit **jewelry** booths to 15% of a show so please send in early.
- There is electricity available at no charge. We encourage you to have lights and decorate your booth with greens, etc., to create a glowing holiday ambiance. Please bring extension cords.
- **Booths are 10 X 10.** Tables and chairs are available for rent (see application). **No tablecovers provided.**
- Security will be provided for Friday and Saturday nights.
- **Set-up will be on Friday from 3:00 pm to 8:00 pm and Saturday morning from 7:30 am to 9:30 am**
- Crafters are allowed to park in a designated area behind the Prairie Events Center during the show.
 - No refunds due to weather or other occurrences beyond our control.
 - No pets allowed except for trained animals assisting the disabled.
 - **We will provide forms for Illinois sales tax collection. We are required to furnish the state with your contact info.**
 - You are required to remain with your booth set up for the duration of the show. If you take down early; you will be removed from the mailing list. (exceptions due to weather or any prearrangements made)
 - No imported or commercially made items.
 - All items must be handcrafted, high quality arts and crafts made by the exhibiting artist or partner. Art of the Heartland reserves the right at its sole discretion to remove any questionable items or if it determines in its sole opinion that your items are questionable; you will be asked to leave the show with no refund of your booth fee.
 - All participants affirmatively represent that no copyright, trademark, patent or other intellectual property has been infringed upon in any way including but not limited to the design, manufacture, display or sale of any products at our shows.
